HOW DOES UROJAS COMMUNITY SERVICES WORK?

Urojas Community Services (UCS) assists individuals and families in finding housing and support systems to reduce chemical dependency and establish pathways to independent living by motivating individuals to advance from client into constituent.

These case management services are rare and community friendly which has served over 2500 families in the past. It truly works by meeting the people right where they are and advancing the process without the hassles of waiting and turn downs, we have been able to manage at this level for over 12 years.

The subsidize deposit program to our providers have gone a long way.

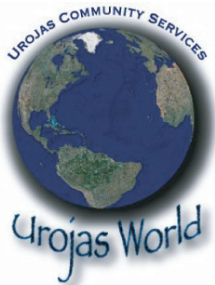
CASE MANAGEMENT SYSTEM

Upon the client arriving, they sit down with a UCS Case Manager who is an intake specialist. All information is taken including background history along with a detailed needs assessment which remains confidential. Then an amount will be pledged for housing if that's the immediate need.

Upon this agreement, the case is transferred to the Intake Coordinator who is the active Executive Director. Potential site locations are scoped out using all options to locate a bed or make the right connection for the need of the client. Upon the location or need the Operations Manager then carries out the task of assisting the Client with furnishings, care packages, grooming, medical attention, pharmacy prescriptions, and reunified with children and to move out of old location.

Client at some point becomes independent enough to no longer rely on Urojas for immediate needs, but able to maintain a good spiritual and business relationship by sharing how they received the help and support, they show us by recruiting and advocating. And the option to enroll in classes at Laney College. We follow up to 90 days upon independence.

Urojas Community Services has partnered with several groups, organizations and governmental agencies to foster entrepreneurship and economic growth for the clients and members of Urojas Community Services.



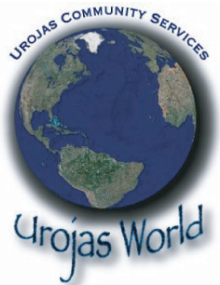
EMPLOYMENT SERVICES

The hiring process includes the application process as well as passing drug test and other required screening to ensure employment. EXIT STRATEGIES PLAN RE-ENTRY

Urojas Community Services continues to serve as a clean and sober environment for former inmates who return to our community. Urojas Community Services has a system in place for a smooth transition from a co–dependant client to active, responsible, productive and independent citizens. The Urojas Community Services formula provides the former inmate a realistic option of complete life services through a network of partners, organizations and businesses. Urojas Community Services Life Enrichment programs include anger management, parenting and men and women health services. Emergency temporary to permanent placement from State Prisons.

HEALTH SERVICES

The Urojas Community Services works with several medical providers who offer client out reach, crisis assistance, assistance with independent living skills, development of employability and career opportunity services.

HOUSING SERVICES

Urojas Community Services refers all types of housing options for adults with severe mental illness with a variance of housing options, staff supported apartments, licensed facilities, a graduate work-live business park and a variety of subsidized housing units. Urojas Community Services emphasis is on providing a range of options, which provide a structured, supportive, growth oriented environment and fosters the development of skills needed for community living, and community reform on going planning council.

Emergency placement is available at up to 15 housing locations in the Bay Area.

HOW IS UROJAS FUNDED?

Urojas is funded through untraditionalized sources such as Inkind services, and Time Banking. The clients in return would be willing to do Community Service Work, Community Policing which also helps to support or our local vendors , Volunteer support for our NCPC group, Community Coaching which supports and assists our Disabled Population living in our Community in exchange for the Deposit and or Bed to no longer be in a homeless situation.
